APPROVING MAP OF DIVISION HIGHLANDS UNIT NO. 10  
SUBDIVISION AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S  
ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING  
PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by GARY L. McCABE, Registered Civil Engineer, entitled "DIVISION  
HIGHLANDS UNIT NO. 10 Being a subdivision of Lots 1 through 9,  
inclusive, Lots 11 through 56, inclusive, Lots 58 through 61,  
inclusive, Lots 64 through 70, inclusive, and portions of  
Lots 57, 62, and 63, together with Lots A, B, C, D, E, and F,  
subsequently dedicated as Division Street, Leonard Street,  
Alden Street, Bower Street, Rozilla Street, all as closed and  
vacated to public use, and portions of Division Street as  
dedicated to public use, all of W. A. Shaules Company Subdivision,  
according to Map thereof No. 1437, filed in the office of the  
County Recorder of San Diego County, May 10, 1912, and a portion  
of Pittsburgh Avenue as closed and vacated to public use, and  
those portions of Pittsburgh Avenue and 65th Street (formerly  
known as Klauber Avenue) as dedicated to public use according  
to Map thereof No. 749, filed in the office of the County  
Recorder of San Diego, May 6, 1893, all being in the City of  
San Diego, County of San Diego, State of California.", is made  
in the manner and form prescribed by law and conforms to the  
surrounding surveys; that said map and the subdivision of land  
shown thereon is hereby approved and accepted; and said Council

hereby accepts on behalf of the public, the following: Agapanthus Drive, Moraea Street, Stamen Court, Stamen Street and a portion of Varney Drive, a portion of Pittsburgh Avenue and a portion of 65th Street, for public purposes; and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, CHILCOTE, INC., that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 745774, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of DIVISION HIGHLANDS UNIT NO. 10.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
