BE IT RESOLVED, by the Council of The City of San Diego as follows:


1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with THE ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY, a Delaware corporation, for the engineering design and construction of automatic crossing gates at CROSBY STREET (Crossing No. 2-269.4), in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 755626.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$32,000 from Gas Tax Reserve Fund 220 (CIP 90-220) to Annual Allocation, Railroad Warning Devices Fund 244 (CIP 64-004, and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for the above-referenced project.

3. That the City Manager be and he is hereby authorized to request reimbursement of one-half of the actual costs of City's share from the California Public Utilities Commission's Crossing Protection Fund.
