BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized to submit four claims to the COMPREHENSIVE PLANNING ORGANIZATION (CPO) for Local Transportation Funds in the amount of \$259,000 for construction of four bikeways at the following locations:

1. East Mission Bay Drive Bridge at Tecolote Creek.
2. Upas Street, between Seventh Avenue and Richmond Street, via Route 163 Bridge.
3. Allen Road, between Hotel Circle South and Fort Stockton Drive.
4. Rose Canyon, between Gilman Drive and Genesee Avenue.
