


RESOLUTION No. 216156Adopted on JUN 9 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to reprogram unexpended Model Cities project and activity budgets into previously approved projects and activities according to appropriate directives from the City Council in order to conclude all Model Cities closeout activities, and further that the City Manager be authorized to negotiate and execute an agreement with the Department of Housing and Urban Development for the purpose of enabling the City to expend grant funds for excepted program activities as set forth in Exhibit A which is attached hereto and incorporated herein, after the grant assistance completion deadline of June 30, 1976.
