WHEREAS, The City of San Diego has entered into a First Amendment to Agreement, City Clerk Document No. 752674, with the San Diego Community College District as authorized by City Council Resolution No. 214209 for the purpose of implementing the Model Cities Educational/Cultural Complex Project; and

WHEREAS, certain additional expenditures have now become necessary for the proper completion of said project by June 30, 1976; and

WHEREAS, the amount of \$150,000 is now available by reprogramming certain Model Cities funds to be used for such purposes as more fully set forth in the revised Project Information Sheet, Budget and Project Work Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a contract modification agreement with the SAN DIEGO COMMUNITY COLLEGE DISTRICT, pursuant to the terms and conditions set forth in the form of modification of agreement on file in the office of the City Clerk as Document No. 755545, and further that the amount of \$150,000 be reprogramed from Model Cities funds and be utilized for the above stated purpose.
