BE IT RESOLVED, by the Council of The City of San Diego as follows:

R76-2573

1. That the bid of \$29,980.00 by DBX, Inc., dba Perry Electric, a corporation for the CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT EBERS STREET AND VOLTAIRE STREET AND AT CATALINA BOULEVARD AND NARRAGANSETT AVENUE, SCHEDULE III, in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 754968.
2. That the expenditure of \$18,290.00 is hereby authorized out of the Gas Tax Fund (Fund 220); that the expenditure of \$22,390.00 is hereby authorized out of the Federal Revenue Sharing Fund (Fund 2385); that the expenditure of \$4,835.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT EBERS STREET AND VOLTAIRE STREET AND AT CATALINA BOULEVARD AND NARRAGANSETT AVENUE, SCHEDULE III, in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$35,510.00 from CIP 62-104 (6) to Gas Tax Unallocated Reserve, CIP 90-220.
