2. That the expenditure of \$3,036.00 is hereby authorized out of the Gas Tax Reserve Fund (Fund 220); that the expenditure of \$43,000.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CORONADO AVENUE AT THE SAN DIEGO AND ARIZONA EASTERN RAILWAY COMPANY RIGHT-OF-WAY in the City of San Diego, and related costs.
