1. That the bid of \$17,974.00 by DBX, Inc., a corporation dba Perry Electric for the CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF FRIARS ROAD AND VIA LAS CUMBRES in the City of San Diego, California is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 754972.
2. That the expenditure of \$24,984.00 is hereby authorized out of the Gas Tax Fund (Fund 220); that the expenditure of \$2,165.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF FRIARS ROAD AND VIA LAS CUMBRES in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$17,818.00 from CIP 62-106 to Gas Tax Reserve, CIP 90-220.
