1. That the bid of \$645,878.00 by Wal-Con Construction Corp. & John M. Artukovich, a joint venture for the TECOLOTE CANYON TRUNK SEWER in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 75442.
2. That the expenditure of \$794,000.00 is hereby authorized out of the Sewer Revenue Fund (Fund 506) of the City of San Diego solely and exclusively for the purpose of providing funds for TECOLOTE CANYON TRUNK SEWER in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$273,000.00 within the Sewer Revenue Fund (Fund 506) from the Unallocated Reserve (69.97) to CIP City Force and Contract (64.92).
