


RESOLUTION No. 216187Adopted on JUN 16 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of AVCO COMMUNITY DEVELOPERS, INC., a California corporation who acquired title as Rancho Bernardo, Inc., a California corporation, executed in favor of The City of San Diego, bearing date of January 30, 1976, conveying to said City an easement for a right-of-way for a public street and incidents thereto, through, over, under, upon, along and across a portion of Rancho San Bernardo, according to Map thereof recorded in Book 2, Page 462 of Patents, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named PASEO DEL VERANO NORTE.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
