

RESOLUTION No. 216194Adopted on JUN 16 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of LEON HALL FISH, aka Leon Hall Fish, Sr.; EDWARD C. HALL and MAE MAC DONALD HALL, executed in favor of The City of San Diego, bearing date of April 9, 1976, conveying to said City a portion of Pueblo Lot 1276 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which map was filed in the office of the County Recorder of San Diego County, November 14, 1921 and is known as Miscellaneous Map No. 36, be and the same is hereby approved.

That the expenditure of not to exceed \$58,400 from Environmental Growth Fund 2505 for acquisition costs of the above described parcel of land is hereby authorized and approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
