

RESOLUTION No. 216195

Adopted on JUN 16 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of ELSIE FARES and JANE SARAH FARES, unmarried sisters as joint tenants, and SOPHIA FARES, widow, executed in favor of The City of San Diego, bearing date of November 11, 1975, conveying to said City an easement for a right of way for a public street and incidents thereto, through, over, under, upon, along and across a portion of Lot 26 of East Redlands, according to Map thereof No. 816, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named EL CAJON BOULEVARD.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
