


RESOLUTION No. 216197Adopted on JUN 16 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PENASQUITOS, INC., an Illinois corporation, executed in favor of The City of San Diego, bearing date of May 12, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Genesee Highlands Unit No. 5, according to Map thereof No. 7178 filed in the Office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named CAMINO TRANQUILO; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named VIA TRANQUILO; and the land therein conveyed as Parcel 3 is hereby dedicated as and for a public street and the same is hereby named PLAYMOR TERRACE.

That the City Clerk is hereby authorized and directed to file said deed, upon acceptance with the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
