WHEREAS, the group has proposed a project to explore and test proportional scheduling methods in six member cities, to include San Diego; and

WHEREAS, member city Santa Clara will be the lead city and has applied for a Community Development Block Grant to fund the proposed program; and

WHEREAS, the other member cities have been requested to indicate their support of said proposal and willingness to participate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the proposal of the California Innovation Group (CIG) for a Government Employee Productivity Project entitled "Improved Work Scheduling for Urban Service Delivery System Personnel," on file in the office of the City Clerk as Document No. 755612, be and the same is hereby supported and endorsed by the City Council.
