


RESOLUTION No. 216207

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Fourth Amendment to Agreement with AMERICANS FOR INDIAN FUTURE AND TRADITION, the originals of said agreement and First, Second and Third Amendments thereto are on file in the office of the City Clerk as Document Nos. 749834, 749910, 752284 and 753086, respectively, for the purpose of increasing the total amount of Comprehensive Employment and Training Act of 1973 Title II funding to \$295,699 for the Public Service Employment Program and extending said program to January 31, 1977, pursuant to the terms and conditions set forth in the form of Fourth Amendment to Agreement on file in the office of the City Clerk as Document No. 755653.
