

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Fifth Amendment to Memorandum of Understanding with the SAN DIEGO COMMUNITY COLLEGE DISTRICT, the originals of said Memorandum of Understanding and First, Second, Third and Fourth Amendments thereto are on file in the office of the City Clerk as Document Nos. 749831, 750008, 752347, 752997 and 755291, respectively, for the purpose of increasing the total amount of Comprehensive Employment and Training Act of 1973 Title II funding to \$1,094,614 for the Public Service Employment Program and extending said program to January 31, 1977, pursuant to the terms and conditions set forth in the form of Fifth Amendment to Memorandum of Understanding on file in the office of the City Clerk as Document No. 755655.
