


RESOLUTION No. 216210

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Sixth Amendment to Memorandum of Understanding with the SAN DIEGO UNIFIED SCHOOL DISTRICT, the originals of said Memorandum of Understanding and First, Second, Third, Fourth and Fifth Amendments thereto are on file in the office of the City Clerk as Document Nos. 749832, 750009, 750139, 752046, 752998 and 755292, respectively, for the purpose of increasing the total amount of Comprehensive Employment and Training Act of 1973 Title II funding to \$5,231,887 for the Public Service Employment Program and extending said program to January 31, 1977, pursuant to the terms and conditions set forth in the form of Sixth Amendment to Memorandum of Understanding on file in the office of the City Clerk as Document No. 755656.
