


RESOLUTION No. 216212Adopted on JUN 16 1976

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Fourth Amendment to Memorandum of Understanding with the UNIVERSITY OF CALIFORNIA, SAN DIEGO, the originals of said Memorandum of Understanding and First, Second and Third Amendments thereto are on file in the office of the City Clerk as Document Nos. 750055, 752345, 753089 and 755294, respectively, for the purpose of increasing the total amount of Comprehensive Employment and Training Act of 1973 Title II funding to \$544,350 for the Public Service Employment Program and extending said program to January 31, 1977, pursuant to the terms and conditions set forth in the form of Fourth Amendment to Memorandum of Understanding on file in the office of the City Clerk as Document No. 755658.
