


RESOLUTION No. 216213

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Third Amendment to Memorandum of Understanding with the SAN DIEGO REGIONAL EMPLOYMENT AND TRAINING CONSORTIUM, the originals of said Memorandum of Understanding and First and Second Amendments thereto are on file in the office of the City Clerk as Document Nos. 749912, 753088 and 755293, respectively, for the purpose of increasing the total amount of Comprehensive Employment and Training Act of 1973 Title II funding to \$43,790 for the Public Service Employment Program and extending said program to January 31, 1977, pursuant to the terms and conditions set forth in the form of Third Amendment to Memorandum of Understanding on file in the office of the City Clerk as Document No. 755659.
