

RESOLUTION NO. 216228Adopted on JUN 23 1976

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Alvin A. Beckett Robert G. Brown Therese M. Haberstroh	Police	\$600	Mr. Beckett and Mr. Brown are Police Officers, and Ms. Haberstroh is an Intermediate Stenographer in the Investigations Bureau. They suggested that a minimal monetary fee be charged for Solicitor's Registration Cards to offset the work involved in issuance. This will produce an estimated \$9,281 in revenue annually. A partial award is being made pending final 12-month review of the suggestion.
Steven W. Zeiss	General Services	\$480	Mr. Zeiss is an Electrician's Apprentice II in the Buildings Division. He suggested that bad diffusers in the main Library be replaced with a better and less expensive system. This suggestion has saved \$4,777 in equipment and installation costs.
Ted E. Suter	Police	\$180	Mr. Suter is a Police Detective in the Traffic Bureau. He suggested that the Hit and Run Report be revised to incorporate needed information contained on the Hit and Run Follow-Up Investigation and Cancellation Report. It is estimated that the revised report will save \$1,814 per year in time while eliminating the need to print the follow-up report.
