Norman V. Newton	Police	\$ 85	Mr. Newton is a Police Officer in the Patrol Bureau. He suggested that traffic warnings be printed in Spanish to prevent calling a bilingual officer to the scene. It is estimated that this suggestion will save \$1,708 yearly in officers' time. A partial award is being made pending final 12-month review of the suggestion.
Rita M. Domler	Water Utilities	\$ 80	Ms. Domler is a Field Representative in the Customer Records Division. She suggested that certain billing notices be placed on different size post cards to conform with Post Office regulations. This saves \$785 in postage costs.
Mary L. Holt	Planning.	\$ <b>7</b> 5	Ms. Holt is a Senior Drafting Aide. She suggested that post cards be used to notify property owners of hearings concerning proposed zonings, variance and conditioned use permits. This suggestion saves an estimated \$1,496 in postage costs. A partial award is being made pending final 12-month review of the suggestion.
