WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Norman V. Newton	Police	\$ 85	Mr. Newton is a Police Officer in the Patrol Bureau. He suggested that traffic warnings be printed in Spanish to prevent calling a bi-lingual officer to the scene. It is estimated that this suggestion will save \$1,708 yearly in officers' time. A partial award is being made pending final 12-month review of the suggestion.
Rita M. Domler	Water Utilities	\$ 80	Ms. Domler is a Field Representative in the Customer Records Division. She suggested that certain billing notices be placed on different size post cards to conform with Post Office regulations. This saves \$785 in postage costs.
Mary L. Holt	Planning.	\$ 75	Ms. Holt is a Senior Drafting Aide. She suggested that post cards be used to notify property owners of hearings concerning proposed zonings, variance, and conditioned use permits. This suggestion saves an estimated \$1,496 in postage costs. A partial award is being made pending final 12-month review of the suggestion.
