

RESOLUTION NO. 216231

Adopted on JUN 23 1976

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Louis Denov	Transportation	\$ 60	Mr. Denov is an Electronic Technician in the Communications and Electrical Division. He suggested that a 70-volt Monitor System be installed at several locations rather than a 10 Channel System. This suggestion saved a total of \$583 in parts and labor of installation.
Robert V. Brock	Fire	\$ 25	Mr. Brock is a Firefighter. He suggested that the use of Emulsion Bowl cleaner be discontinued because it ruins the grouting between the flooring. This suggestion will prevent repairs.
Steven J. Morgan	Park & Recreation	\$ 25	Mr. Morgan is a Caretaker in the Recreation Division. He designed a trash collector to be used in sand that filters out glass, rocks, and other foreign objects. Although savings were not calculable, a \$25 award is recommended for the design of this safety device.
Carol S.B. Harrison	Employee Services	\$ 20	Ms. Harrison is an-Intermediate Typist. She suggested that a monthly status up-date memo be printed rather than individually typed. This saves \$191 a year in professional and clerical time.
Mary Lou Bernitz	Park & Recreation	\$ 10	Ms. Bernitz is an Intermediate Typist in the Aquatics Division. She suggested that groups reserving youth camping space be required to include a self-addressed stamped envelope for receipt of confirmation. This saves \$70 per year in postage and envelopes.
