BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$336,970.00 by Petar Artukovich Construction Co., Inc., a corporation for the SEWER AND WATER MAIN REPLACEMENT - GROUP 32 in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 754966.
2. That the expenditure of \$398,000.00 is hereby authorized out of the Sewer Revenue Fund (Fund 506); that the expenditure of \$44,200.00 is hereby authorized out of the Water Revenue Fund (Fund 502) of the City of San Diego solely and exclusively for the purpose of providing funds for SEWER AND WATER MAIN REPLACEMENT - GROUP 32 in the City of San Diego and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$44,200.00 within the Water Revenue Fund (Fund 502) from the Unallocated Reserve (69.79) to CIP City Force and Contract (66.92).
