R7C-2641

1. That the bid of \$53,274.98 by Rick Stadelman, an individual dba R.S. Construction Company for the MIRAMAR FILTRATION PLANT SLUDGE DISPOSAL SYSTEM in the City of San Diego, California is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 755038.
2. That the expenditure of \$73,680.00 is hereby authorized out of the Water Revenue Fund (Fund 502) of the City of San Diego solely and exclusively for the purpose of providing funds for the MIRAMAR FILTRATION PLANT SLUDGE DISPOSAL SYSTEM in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$4,320.00 from CIP 72-034 (6) to Water Revenue Fund (Fund 502) Unallocated Reserve.




