BE IT RESOLVED, by the Council of The City of San Diego as follows: *R. 76 - 2647*

1. That the bid of \$43,717.00 by Wilcox Electric Inc., dba Arrow Electric, a corporation, for the MODIFICATION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT GRAPE STREET AND PACIFIC HIGHWAY: 12TH AVENUE AND BROADWAY: 30TH STREET AND ADAMS AVENUE: EL CAJON BOULEVARD AND OREGON STREET: 28TH STREET AND NATIONAL AVENUE AND MINOR IMPROVEMENTS AT SEVEN ADDITIONAL LOCATIONS in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 755035.
