2. That the expenditure of \$21,000.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for the MT. ACADIA PARK SAFETY LIGHTING in the City of San Diego, and related costs.
