

RESOLUTION NO. 216257 JUN 28 1976 R.76-2590

APPROVING MAP OF UNIVERSITY TOWNE CENTER UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, entitled "UNIVERSITY TOWNE CENTER UNIT NO. 1 Being a subdivision of portions of Pueblo Lots 1302, 1303, 1307 and 1308, according to Miscellaneous Map No. 36, in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Nobel Drive, Towne Centre Drive, Lombard Place and a portion of Genesee Avenue, together with the right of way for pedestrian and non-motor vehicular use, for public purposes, and said streets, portion of street and right of way are hereby declared to be public streets, portion of public street and public right of way and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in paragraphs 1 and 2 of the certificate signed by the Owners for drainage, electrical and general utility facilities; as granted and shown on said map and subject to the conditions expressed therein.
