BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PENASQUITOS, INC., an Illinois corporation, who acquired title as University City, a California corporation, executed in favor of The City of San Diego, bearing date of May 26, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Pueblo Lots 1302 and 1303, according to Miscellaneous Map No. 36 on file in the office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named TOWNE CENTRE DRIVE; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named NOBEL DRIVE.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
