

RESOLUTION No. 216267


Adopted on JUN 23 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of VIRGINIA F. McDOWELL, a married woman, and JAMES M. Mc DOWELL, her husband, executed in favor of The City of San Diego, bearing date of May 5, 1976, conveying to said City a permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lot 18 of Soledad Terrace, according to Map thereof No. 1618, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named LOS ALTOS ROAD.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
