

RESOLUTION No. 216270Adopted on JUN 23 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with RWA ENVIRONMENTAL GROUP, a California corporation, to provide professional engineering services for design of the ROSE CANYON BIKEWAY, PHASE 2, between Gilman Drive and Genesee Avenue, and the SORRENTO VALLEY BIKEWAY, between Roselle Street and Eastgate Mall, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 755737.

BE IT FURTHER RESOLVED, that the expenditure of \$19,000 and \$7,000 is hereby authorized out of Capital Outlay Fund 245 and Gas Tax Fund 220, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services.
