That the City Manager be and he is hereby fully authorized to expend funds consisting of City-authorized and private contributions in an amount not to exceed \$4,000 for the purchase of fireworks for the City's Bicentennial Fireworks Display to be held on July 4, 1976 in the Clairemont area under the auspices and complete control of the Clairemont Town Council,

it being understood that the City's role is limited to funding only and that said Town Council assumes all responsibility for the operation and production of the fireworks display.
