That the City Manager be, and he is hereby authorized and empowered to submit, for and on behalf of said City, a grant application to the Department of Health, Education and Welfare for the purpose of funding the Southeast Involvement Project through the Runaway Youth Act, Title III, Juvenile Justice and Delinquency Prevention Act for an amount not to exceed \$75,000 for the period from July 1, 1976 to June 30, 1977, the form of grant application is on file in the office of the City Clerk as Document No. 755792.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept the grant in the event the Department of Health, Education and Welfare consents to funding said project.
