BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SENIOR CITIZENS FEDERATION, INC., for the purpose of preparing and distributing food for the hot meals program (Senior Citizens Project) during the time period from July 1, 1976 to December 31, 1976, and that an amount not to exceed \$46,325 be authorized for expenditure from Community Development Block Grant funds for this purpose to be contingent upon Council approval of the total Senior Citizens Project, pursuant to the applicable terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 755820.

BE IT FURTHER RESOLVED, that revenues generated in excess of \$10,000 from the program be used to pay costs incurred during the operation of the program.
