BE IT RESOLVED, by the Council of The City of San Diego as follows:

R 76-2722

1. That the bid of \$606,000.00 by Viewland Investment Co., Inc. dba Viewland Construction Company, a corporation for the RANCHO BERNARDO LIBRARY AND MIRA MESA LIBRARY, SCHEDULES 1, 1V AND V in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 755067. *IV*
2. That the expenditure of \$50,500.00 is hereby authorized out of the Community Buildings Improvement Bond Fund (Fund 726); that the expenditure of \$736,000.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for RANCHO BERNARDO LIBRARY AND MIRA MESA LIBRARY, SCHEDULES 1, 1V AND V in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$56,750.00 from CIP 35-014 and \$56,750 from CIP 35-016 to Capital Outlay Reserve, CIP 90-245.
