R76-2718

1. That the bid of \$65,470.00 by Mesa Construction Inc., a corporation, for ARCHERY CENTER IMPROVEMENTS in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 755200.
2. That the expenditure of \$81,770.00 is hereby authorized out of the Park and Recreation Bond Funds (Fund 725) of the City of San Diego solely and exclusively for the purpose of providing funds for ARCHERY CENTER IMPROVEMENTS in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$8,230.00 from CIP 21-710 (6) to Park and Recreation Bond Fund Unallocated Reserve, CIP 90-725.
