That the expenditure of \$31,600.00 is hereby authorized out of the Gas Tax Funds (Fund 220); that the expenditure of \$12,800.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF FRIARS ROAD BIKEWAY FROM ULRIC STREET TO SEA WORLD DRIVE in the City of San Diego, and related costs.
