R76-2717

1. That the bid of \$8,580.50 by Griffith Company, a corporation, for CONSTRUCTION OF OCEAN BOULEVARD BIKEWAY BETWEEN DIAMOND STREET AND LAW STREET in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 755143.
2. That the expenditure of \$18,600 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF OCEAN BOULEVARD BIKEWAY BETWEEN DIAMOND STREET AND LAW STREET in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$1,400 from CIP 58-012(6) to Capital Outlay Reserve, CIP 90-245.
