The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said Council has rejected that Portion of Lot 35 marked "Reserved for Future Street," as shown on this map; that that certain easement for slope rights as granted and shown on this map are accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and that those easements listed in paragraphs 1 and 2 of the Owner's certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
