
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of JOSEPHINE WALKER, an unmarried woman, executed in favor of The City of San Diego, bearing date of May 3, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lots 20, 21 and 22 of Sunshine Gardens, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named IMPERIAL AVENUE.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.

That the expenditure of \$850.00 from Gas Tax Fund 220 is hereby authorized solely and exclusively to provide for acquisition of the above described property and related expenses.
