BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Utilities Agreement No. 15287-A with the STATE DEPARTMENT OF TRANSPORTATION for relocation of water facilities on Interstate Route 8 between 0.5 mile west and 1.2 miles east of Route 163, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 755808.

BE IT FURTHER RESOLVED, that the expenditure of \$51,965 is hereby authorized out of Water Revenue Fund 502 for the sole and exclusive purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the relocation of said water facilities, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
