BE IT FURTHER RESOLVED, that the expenditure of \$51,965 is hereby authorized out of Water Revenue Fund 502 for the sole and exclusive purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the relocation of said water facilities, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
