BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$179,485.50 by R. E. Hazard Contracting Co., a corporation, for the CONSTRUCTION OF STREET IMPROVEMENTS FOR THE SAN DIEGO COMMUNITY COLLEGE EDUCATIONAL AND CULTURAL COMPLEX in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 755192.
2. That the expenditure of \$150,400.00 is hereby authorized out of the Capital Outlay Fund (Fund 245); that the expenditure of \$103,000.00 is hereby authorized out of the Model Cities Fund (Fund 2903) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF STREET IMPROVEMENTS FOR THE SAN DIEGO COMMUNITY COLLEGE EDUCATIONAL AND CULTURAL COMPLEX in the City of San Diego, and related costs.
