BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$92,397.70 by R. E. Hazard Contracting Co., a corporation, for the IMPROVEMENT OF OSLER STREET - 400 FEET EAST OF ULRIC STREET TO GENESEE AVENUE, BASE BID AND ADDITIVE ALTERNATE #1 in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 755039.
2. That the expenditure of \$116,045.72 is hereby authorized out of the Gas Tax Fund (Fund 220); that the expenditure of \$24,135.77 is hereby authorized out of the Capital Outlay Fund (Fund 245); and that the expenditure of \$17,187.50 is hereby authorized out of the Deposit Trust Fund (Fund 3021) of the City of San Diego solely and exclusively for the purpose of providing funds for the IMPROVEMENT OF OSLER STREET - 400 FEET EAST OF ULRIC STREET TO GENESEE AVENUE, BASE BID AND ADDITIVE ALTERNATE #1 in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$35,847.28 from CIP 52-221 (6) to Gas Tax Unallocated Reserve, CIP 90-220.
