Hazard Contracting Co., a corporation, for the IMPROVEMENT OF SIXTH AVENUE BETWEEN UPAS STREET AND PENNSYLVANIA AVENUE in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 755144.
2. That the expenditure of \$22,546.00 is hereby authorized out of the Gas Tax Fund (Fund 220); that the expenditure of \$249,678.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF SIXTH AVENUE BETWEEN UPAS STREET AND PENNSYLVANIA AVENUE in the City of San Diego, and related costs.
