WHEREAS, the Council authorized a contract with Proprietary Computer Systems, Incorporated (PCS) in 1964 for text-editing capability through the time-shared use of a computer for recording, editing and composing camera ready copy for printing of the budget document; and

WHEREAS, the Council subsequently renewed the agreement with PCS for fiscal year 1975 and fiscal year 1976; and

WHEREAS, the proposed agreement is for continuation of service with PCS for a one-year period ending June 30, 1977;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered, for and on behalf of said City, to execute an agreement with PROPRIETARY COMPUTER SYSTEMS, INC., for computer time-sharing services for a period of one year ending June 30, 1977, for a sum not to exceed \$13,200, pursuant to the terms and conditions set forth in the APL/ATS Time Sharing Contract on file in the office of the City Clerk as Document No. 755810.
