BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Utilities Agreement No. 15288 with the STATE DEPARTMENT OF TRANSPORTATION for relocation of sewer facilities on Interstate Route 8 between 0.5 mile west and 1.2 miles east of Route 163, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 755822.

BE IT FURTHER RESOLVED, that the expenditure of \$20,000 for preliminary engineering (reimbursable by State) and \$17,172 for depreciation credits is hereby authorized out of Sewer Revenue Fund 506 for the sole and exclusive purpose of providing funds for said purpose.
