2. That the expenditure of \$76,000.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF CHOLLAS OPERATIONS STATION - SERVICE STATION ADDITION SCHEDULE II in the City of San Diego, and related costs.
