WHEREAS, McKEON CONSTRUCTION COMPANY filed a subdivision map, OCEAN BLUFFS SUBDIVISION, on January 1, 1973, and in conjunction therewith paid The City of San Diego park fees in the sum of \$61,304.10; and

WHEREAS, said park fees were computed at \$1,650.00 per acre, as provided for land zoned R-2-A; and

WHEREAS, The City of San Diego rezoned the land covered by the subdivision to R-2 Zone on November 27, 1973; and

WHEREAS, the park fees for the subdivision based on R-2 zoning are computed at \$39,363.10, or \$1,000.00 per acre; and

WHEREAS, McKeon Construction Company is entitled to a refund of the difference between the fees calculated for R-2A and R-2 zoned property in the amount of \$21,941.00; and

WHEREAS, Neighborhood Park District Fund 11720 has a balance of \$3,204.85, which is \$18,736.15 less than the amount needed to provide for the refund; and

WHEREAS, funds are available in Park and Recreation Building Permit Fee Fund 16730 that may be transferred to Fund 11720; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That McKeon Construction Company is entitled to a refund of \$21,941.00.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is authorized to transfer \$18,736.15 from Park and Recreation Building Permit Fee Fund 16730 to Neighborhood Park District Fund 11720.
