WHEREAS, Assistant City Treasurer Don Searles has been appointed as the Acting City Treasurer while a search is being conducted for a person to permanently fill the City Treasurer's position; and

WHEREAS, there are numerous pending Treasurer projects and tasks that are both complex and time consuming; and

WHEREAS, it is thus desirable, in the interim period until a new City Treasurer can be appointed, that the City enter into a consultant agreement with Gordon J. Feeley so that needed assistance and expertise may be obtained; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby empowered to enter into an agreement for and on behalf of said City with GORDON J. FEELEY for consulting services for the period June 5, 1976 through August 31, 1976 and providing for compensation in an amount not to exceed \$1,500 so that a new City Treasurer may be appointed and become familiar with the duties of the office, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 755988.
